



# WILDLIFE SWEEPS

Wildlife sweeps are mandatory year-round in Alberta, as both federal and provincial legislation impose legal obligations for safeguarding breeding, nesting, and denning wildlife.

The following should be considered when planning a project:

- Wildlife and their habitats are subject to varying legal protections based on factors like location, activity type, time of year, and regulatory jurisdiction.
- Certain wildlife features, such as dancing grounds (leks), den sites, amphibian breeding ponds, and nests, have associated regulatory setback guidelines.
- Recommended setback distances from [wildlife features](#) depend on factors such as:
  - type of feature and wildlife
  - type of development
  - level of disturbance
  - construction schedule
- Non-migratory birds are protected under the Alberta Wildlife Act and may commence nesting as early as January, depending on weather conditions.
- The general migratory bird nesting period spans from mid-March to late August, with regional and weather-dependent variations.
- The 2022 Migratory Birds Regulations offer protection to nests of migratory birds containing live birds or viable eggs. Year-round protection is extended to inactive and active nests of 18 migratory bird species listed in Schedule 1 of the regulations, whose nests are frequently reused. Violation of legal requirements may occur if an active nest of a Schedule 1 species is damaged, destroyed, or disturbed without adhering to the conditions outlined in section 5(2) of the regulations.
- Wildlife assessments must be conducted by qualified individuals possessing the requisite skills, experience, education, and training.

### TECHNICAL ALERT

#### HOW WE CAN HELP

To prevent an activity from contravening federal and provincial legislation or approval conditions of a project authorization, a wildlife sweep is required prior to construction where wildlife and wildlife habitat may be impacted.

Additionally, if project disturbance activities are not continuous throughout a project area and for the duration of a project following a wildlife sweep, additional sweeps are required to ensure wildlife have not initiated a new nest or den during periods of project inactivity.


